Anthropology 553 Primate Behavior Research Design

Prerequisite: Consent of the department. **Co-requisites: ANTH 552 and ANTH 505.02**

1- Course Description: This course will build on the students' knowledge of primatology theory by providing lectures, readings, and discussions on important concepts in primatology. It will also provide students the opportunity to design a small research project to be implemented in the field. This course will take place in Calgary for a full week before departure for Ghana. We will introduce issues surrounding biodiversity in West Africa. We will review important notions in primate behavioral ecology, as well as learning about primate data collection and ecological data collection. We will also have sessions on group dynamics and social etiquette in Ghana to prepare students to "life in the field". The sessions in ANTH 553 are designed to give tools to the students to be able to operate and perform in the field component of the fieldschool (ANTH 552).

2- Learning Outcomes:

At the end of ANTH 553, students are expected to:

- Know key elements of Ghana's political and natural history, to be able to contextualize and ground their field experience in this country.
- Be able to explain foundational concepts and methods of data collection in primatology.
- Be able to use primary literature in primatology to design a small research project.
- Formulate research hypotheses to guide their data collection
- Demonstrate their readiness to proceed to the research implementation step of the field school (ANTH 552).
- Be equipped to face the demands of primatology fieldwork in Ghana.
- Be engaged in the group as a full participant to the program.
- Be able to navigate the multiple challenges associated with conducting fieldwork in a small community, in a small group, in a new environment, with a heavy workload.

3- Course Requirements:

3.1- Exam on material presented in lectures, movie and guest lectures (50%)

3.2- **Presentation on research project** during Calgary week (20%): evaluation will be based on whether students have demonstrated an understanding of individual texts, but also on the integration of the various texts provided towards the actual project. Students will be expected to be able to comment on the significance of their project; why is it interesting to study this particular question. Clarity of the argument, quality of presentation, capacity to engage the students will be evaluated. I do not encourage students develop powerpoint presentations; given the limited amount of time at our disposal, it is more useful to invest time in content.

3.3- **Participation** (30%); A PASSING GRADE ON THIS COMPONENT IS A REQUIREMENT TO PASS THE COURSE. Active presence during lectures, working sessions, exercises and preparation sessions. Ability to articulate questions, participate to group discussion, and generally speaking, having a <u>positive contribution to group</u> <u>dynamics</u> during Calgary week.

There is no textbook required for this course. There is no Registrar's scheduled final exam for this course.

Deferred Exams:

The format of a deferred examination/assignment will likely vary from the original format on the scheduled exam/assignment. For example, it might be essays or short answers rather than multiple choice.
