COURSE DESCRIPTION

Paleoethnobotany is the study of the use of plants by people in the past through archaeological remains and ethnobotanical research with contemporary people. The broad goal is to understand how past people used plants for food and other purposes such as tools, but also to use plant remains to reconstruct past environments. A major objective of the course is to develop an ability to identify plant species from archaeological remains. Identification will focus on macrobotanical carbonized wood and seeds, and microbotanical material including phytoliths, starch grains, and pollen. Techniques for extraction of these remains from archaeological sites, and methods for preparing comparative material, will also be examined. These skills will be developed primarily through hands on lab work. Ethnobotany will be primarily presented by guest speakers.
