#### **COURSE DESCRIPTION**

The course is overview of the relationship between Development and Anthropology, and examines the critiques of development theories and the practical application of anthropological research to development issues. In particular, the anthropological critiques of orthodox theories and models of "development," the socio-cultural impact of development, and culturally sustainable strategies to development will be emphasized. It explores the nature and politics of policy-making, bureaucracy and shifting frameworks of development intervention in a variety of sectors (e.g. livelihood and food security, reproductive health, human rights, foreign aid, technology and technical transfer, environmental policy and natural resources management etc.), with special attention to the specific cultural contexts of development relationships. We will examine the central issues of poverty, its meaning, measurements, and approaches to its eradication/reduction; the work of policy makers, development workers and projects, and the meaning of popular 'participation' and 'empowerment' in development. The shifting profile of non-governmental organizations (NGOs) and civil society in contemporary local and international development will also be explored.

## **OBJECTIVES OF THE COURSE**

Students will have:

- A grasp of the key debates in and critiques of various approaches to anthropology of development;
- A holistic understanding of development encounters from different perspectives, regional and institutional contexts -- how development affects the people it aims to help differently;
- Developed the capacity to conceptualize and ethically reflect on what and how anthropologists can contribute to sustainable development, as well as the strengths and weaknesses of the different approaches that promote sustainable development.

## Guidelines for review

Length of paper: a maximum of 4 PAGES TYPED AND DOUBLED-SPACED in 12 PT FONT, going over may reduce the assignment grade. Page margins should be 1 INCH (2.5 cm) wide, and all pages should be numbered. Double-sided assignments are encouraged to save paper, but are not mandatory. Please include the following on the title page: title of paper, course code, instructor's name, student ID, and date of submission. Please include a minimum of 3-4 properly cited and referenced scholarly peer-reviewed references in addition to the book you have chosen.

- The level of analysis is suitable for a third-year university course.
- A critical analysis requires an evaluation of the arguments made by the author, and this means you have to read carefully to find out what the author's argument(s) is/are. You may find the argument(s) stated in the book's introduction. The next step is to consider what the author provides in subsequent chapters.
- A well-written book will remind readers of the main arguments as it proceeds. The concluding chapter of the book will summarize the author's own appraisal of the argument(s) and evidence. This does not mean that you can read the introduction and conclusion, and write a good review; you need to demonstrate that you know what each chapter contains, and how it contributes to the main argument(s).
- In addition, a critical assessment requires that you assess the argument(s) and comment on whether you think the book meets the author's stated objective(s). This assessment is not a simple option, but a thoughtful evaluation of how well the author has succeeded in convincing you, the reader, of the value of the argument and the evidence used to support it. Your own conclusions should also say something about what you have learned about the subject, having read the book, and what else you might want to know that was not addressed in the book.
- · As you read, it is useful to carry on a "dialogue" with the author, asking yourself if you agree with what is being said, or whether something is missing. You will need to say something about the author's relationship with the subject, and about his/her methods. In some cases, you will have to be a detective to find out what you want to know.
- Correct spelling is important. Use a dictionary and a computer spelling and grammar checker.
- · Create a draft of your review, and then look at it again a day or so later. When you do a second draft, make sure that the ideas follow coherently from one another. Move text around if you need to. Weed out repetitive words and phrases. Vary the length of sentences. Read the review aloud, to see how it "flows." The final product will reflect the care you have put into its creation.
- If you wish, you may use the first person. Also, use the active voice as much as possible.
- Use a correct bibliographical format (both in-text and the final list of references).

It is the student's responsibility to keep a copy of each assignment submitted. Students should be prepared to provide a second copy of their assignment if requested. Students who cannot provide a second copy of their essays may risk receiving a zero grade for this portion of the course. Note: Please hand in your essays directly to your instructor. If it is not possible to do so, a daytime drop box is available in ES 620. A night drop box is also available for approved after-hours submission. Assignments will be removed the following morning, stamped with the previous day's date, and placed in the instructor's mailbox.

# MIDTERM EXAM 30% (November 7, in-class closed-book exam)

This is a closed-book exam designed to test your grasp of the material covered in lectures, tutorials and from course readings up to the date of the exam. This means that you will be expected to have read all the required readings on topics covered in the course up to the date of the exam. The best way to prepare for this exercise is to read and reflect on lectures and course readings. Exams will also cover lectures by guest speakers, and information from videos/films shown in the class. Please note: no alternate dates for the exam will be provided unless the student has been legitimately excused.

# FINAL PAPER 45% (Due: December 5th ) to be collected in class)

The final paper can be structured around the major topics covered in or relevant to the course. Please consult with me if you are in doubt regarding the choice of topic.

- Length of final paper: The paper must not be more than 10 pages doubled-spaced, and must meet all academic standards.
- Working title: The paper must have a working title.
- Clear statement of the problem(s) you want to investigate or explore, including:
  - The theoretical lens you use to construct your research question(s) or argument(s).
  - Brief justification of your choice of topic in relation to the existing literature
- Use of sources:
  - Judicious and balanced use of sources.
  - Credible/authoritative and current sources.
  - o Well-formatted bibliography including ample in-text references. Please consult me if you have any questions regarding how to document sources.
- Level of Analysis:
  - Critical, as opposed to descriptive, analysis.
  - o Clarity and coherence of arguments (note: marks will, in part, be based on the coherence of arguments and clarity of expression).
- A strong conclusion.
- Additional information such as tables, maps, figure, lists of interview questions, etc. can be included.

NOTE: Extensions will only be granted under extraordinary circumstances, not including having too much other work to do. If late assignments are handed in at the Anthropology Office please ensure that they are signed and dated.

It is advised that you keep both a hard copy and an electronic copy of your work. Students should be prepared to provide a second copy of their paper if requested. Students who cannot provide a second copy of their essays may risk receiving a zero grade for this portion of the course.

Note: All written assignments (including, although to a lesser extent, written exam responses) will be assessed at least partly on writing skills. Writing skills include not only surface correctness (grammar, punctuation, sentence structure, etc.) but also general clarity and organization.
