Course Description:

This course will draw from the history and geography of the region to better understand Latin American societies' contemporary issues with an anthropological perspective. This course will emphasize topics related to diversity, inequality, specifically social class, gender relations, indigenous groups, popular culture, violence and global movements. The focus will be on the similarities and differences found across the region.

Course Learning Outcomes:

By the end of the course students will be expected to:

- List cultural and geographical and ethnic differences within the region
- Explain how race and class play a major role in the region dynamics.
- Develop an understanding of the causes and consequences of migration to and from the region.
- Recognize gender ideologies and relationships within the region.
- Identify the link between inequality, poverty, social dynamics and violence in the region.

Course Format

This course will follow an interactive lecture-discussion style format accompanied by student presentations of selected topics, guest speakers and the occasional film or video.

1. Conduct a literature review on the topic? Region chosen through peer reviewed articles published since 2010

Write a five-page report on your findings. The paper should be double-spaced, and single-sided. Use a 12 point, standard font with 1-in margins. Submissions should include a title (title page is optional), an introduction, the body of the literature review, a discussion, and a literature cited section. The optional title page and literature cited section can be on additional pages and will not count towards the five-page maximum length.

2. Prepare a five-minute presentation on your findings, together with a one-page handout for the class, focusing on recent Anthropological research on your findings. Your presentation will be delivered during the week the topic chosen will be covered.
